Mandats importants

 (3d) 360 (Div. Ct.) (successfully defended appeal of small claims trial victory on the basis of a limitation period defence)
- Metropolitan Toronto Condominium Corporation No. 659 v. Truman, [2015] O.J. No. 4500 (successfully represented plaintiff condominium corporation in small claims court action against unit owner for excessive water usage; maximum costs allowable under the small claims court rules were awarded)
